WASHINGTON COUNTIES RISK POOL BOARD OF DIRECTORS MINUTES AUTUMN MEETING, OCTOBER 20, 1995 - 1 Minutes: Dick Brown moved to approve the minutes of the July 28th Annual Meeting at Leavenworth. The motion was seconded by Judy Wilson and approved.

REPORTS:

Executive Committee: Frank Bishop reported on the September 15th Meeting of the Executive Committee.

Executive Director: John Crawford recognized the service of Grays Harbor County Director of Management Services Rose Elway on the Risk Pool Executive Committee, and presented her with a certificate of appreciation. John also presented Walla Walla County Commissioner Lewis Jacky with a Membership Certificate commemorating that county's admission into the Risk Pool.

<u>Finances</u>: Aileen Boren distributed a list of the final costs for purchasing and remodeling the new office building.

<u>Claims</u>: Alicia Johnson reported on two large settlements regarding a shooting by a deputy sheriff, and an automobile accident on an icy county road that was not sanded.

<u>Programs</u>: Jay Winter passed around a training compilation report for 1994-95. He showed a video and gave a presentation on a skid car training program. There was a show of hands directing staff to go forward with a proposal which separated the training from the WCJTC.

<u>Personnel / Salary Committee:</u> Debbie Broughton reported on the work of the Personnel / Salary Committee since the last meeting.

DISCUSSION AND ACTION:

<u>Personnel</u>: Steve Lowe moved to revise the Personnel Policy as recommended by the Personnel Committee, with further changes in Section D.2. to use the March CPI, and to change the name in Section C.5. from "Training Coordinator" to "Programs Director." The motion was seconded by Claude Cox and approved.

Dick Dixon moved to accept the secretary's revised job description. The motion was seconded by Frank Bishop and approved.

Dick Brown moved to set staff salaries for the 1995-96 fiscal year as follows:

Work Plan: Mary Jo Cady moved to approve Board Work Plans for 1996 and 1997. The motion was seconded by Dick Dixon and approved.

Legislative Agenda: The WSAC will hold its Legislative Conference next month. If voters approve the "takings" initiative/referendum in November, a special meeting of the Pool will probably be called to decide whether to clearly exclude Risk Pool coverage and defense costs in our policy documents.

The Board went into executive session from 12:40 p.m. to 1:22 p.m. to discuss personnel matters.

Washington Counties Insurance Fund Service Agreement: Debbie Broughton moved not to renew the Service Agreement with the Washington Counties Insurance Fund, but to extend it for 30 to 60 days if requested. The motion was seconded by Judy Wilson and approved with one dissent.

OTHER BUSINESS:

<u>Future Board Meetings</u>: Debbie Broughton moved to reschedule the Spring Meeting because of a conflict with the WSAC Western District Meting to Thursday, April 25, 1996. The motion was seconded by Dick Brown and approved. The 1996 Summer Workshop and Annual Meeting will be held at the Enzian Motor Inn in Leavenworth on July 11th and 12th.
