<u>CALL TO ORDER / WELCOME</u>: Jill Lowe called the Roundtable to order at 8:30 am and welcomed those in attendance. Around the room introductions took place.

Email Liability, Risk and Retention training: Jill Lowe introduced the training session by giving the background on the development of this class. She stated this was a BETA test of the revised class format and that she is looking for feedback and comments. She then introduced Jordan Peabody with Peabody Communications. Jordan's presentation covered the following topics:

- When to email and when to pick up the phone
- Email structure including the fields (TO, CC, BCC, Addresses, Subjects)

- Email rules and etiquette
- Folder organization

Jill then introduced Leslie Koziara with the Washington State Archives office. Leslie's presentation covered the following topics:

- Email fatigue
- The digital and paper divide (If a document is born digital, it must be retained in a digital format)
- Retention schedules
- Email lawsuits and fines
- Storage

Following the training session, Jill took feedback and comments from the group. Jill then passed out certificates to those attendees that recently earned CPO certification.
